(5 min)	Welcome and Overview This video will examine Grant Modifications for ASES, 21 st CCLC and 21 st CCLC ASSETS programs. The following modifications are available for expanded learning program grantees Partnership Restructure, Fiscal agent change, and School Site Substitution.			
(35 min)	Activity Introduction Test your knowledge with 3 pop quizzes on Grant Modifications. This activity is designed to strengthen knowledge and provide some friendly competition with your colleagues. At the end of this activity, you will have an opportunity to access the California Department of Education's Expanded Learning Division website as a team to locate resources to support you during your grant modification process.		Pass out the Grant Modification worksheet	
	Activity Directions: **Watch the Grant Modification video as a group. <u>PAUSE</u> the video at minute 5:27.			
	 Divide the group into 2 teams. Give teams 5 minutes to collectively insert their responses on one sheet of paper in the <i>Partnership Restructure, Scenarios 1-3</i> activity table. 			Be sure to give the teams a 1 minute, and a 30 second countdown before calling time.



	 Once time is called, resume the video to uncover the correct responses. P<u>AUSE</u> the video just after the answer to Scenario 3 is given. A correct response earns 1 point. An incorrect response receives no points, and should get an "X" marked through the box with the incorrect response. <i>Correct responses must indicate WHY or WHY NOT the scenarios are allowed</i>. Once the scores are tallied for the first round, resume the video and watch as a team. Repeat the above instructions for the next two sections: <i>Fiscal Agent Change, Scenarios 4 & 5 (min 12:27)</i> <i>School Site Substitution, Scenarios 6 & 7 (min 16:54)</i> At the end Scenario 7, the facilitator will add up the team points. The team with the highest number of total points will be declared the winner! 	Feel free to have a group discussion before moving forward!
(10 min)	Reflection Take some time to have dialogue with your team. Probe them with these questions for provide understanding and generate an in depth conversation about specific situations happening in your programs.	Ask the questions provided in order and allow for participants to share their reflections and takeaways.
